Privacy

Please note that in order to process your query we will not share your personal information with any third party, except as required to do so by law. We may also use your information to contact you to ask whether you would like to receive information from Ambienta about events, publications and services provided by the firm that may be of interest to you, but we will not add you to any of our mailing lists without your express and explicit consent.

Cookies

A 'cookie' is a small data file that can be placed on your computer's hard disk or on a Web site server. These cookies do not retrieve information about you stored on your hard drive and do not corrupt or damage your computer or computer files. You are not obliged to accept a cookie that we send to you, and you can in fact modify your browser so that it will not accept cookies. We use cookies on our Web site so that we can display content in a user's preferred language, as selected during a prior visit to our site. We also track how users navigate through our site, in order to enable us to evaluate and improve the site. We use this information to compile statistical data on the use of our Web site, but the information obtained is used on an anonymous, aggregated basis and you cannot be identified from it. When you visit our Web site, our server will record your IP address together with the date, time and duration of your visit. An IP address is an assigned number, similar to a telephone number, which allows your computer to communicate over the Internet. We analyze this data for trends and statistics, and then we discard it.
